We are proposing a plan where the existing \$2.00 convenience fee will be retained by us. Jefferson Parish will only be billed the difference between 2.4% of each card payment less \$2.00. You will not receive any fee for card payments below \$83.32. This includes on-line, phone, or in-person payments.

Our proposed fee for e-check payment is \$.50. We are proposing to retain that fee. The cost to Jefferson Parish for electronic check acceptance will be Zero.
